CAMP CEDAR HILL TROOP CAMPING PROCEDURES 265 BEAVER ST, WALTHAM, MA 02452

PLEASE SHARE THIS INFORMATION WITH ALL ADULTS ATTENDING YOUR EVENT.

DIRECTIONS

From Route 128, take exit 28 toward Belmont on Trapelo Road. Continue 3½ miles to Route 60 (Waverly Oaks Road) intersection and turn right. Go appx 1 mile to the traffic light (Beaver Street), turn right. The Cedar Hill driveway is the second one on the right.

From Mass Pike/Watertown Square - Leave Watertown Square on Route 20 west. Follow about 3 miles, turn right at *John Brewers* (Warren Street). Follow Warren Street about 1 mile to a small blinking light on left. Turn left onto Beaver Street. Follow Beaver Street thru intersection. Cedar Hill driveway is the second one on the right.

MEDICAL EMERGENCIES

Medical emergencies are the responsibility of the troop/group leader. A **certified First Aider** with **First Aid Kit** required for each troop using the site. Please follow the Volunteer Emergency Procedures handout for reporting an accident or illness.

Directions to Newton-Wellesley Hospital, 2014 Washington Street, Newton, MA
At the end of the Beaver Street Lot take a RIGHT onto Beaver Street, turn LEFT
onto Linden Street, turn RIGHT onto US-20/Main Street. Turn LEFT onto Moody
Street, Moody Street becomes Lexington Street. Turn LEFT onto MA-30E/
Commonwealth Avenue. Turn RIGHT onto Washington Street/MA-16. Newton Wellesley
Hospital will be three quarters of a mile on your LEFT.

CANCELLATIONS

WRITTEN notice of cancellation must be received 6 weeks prior to your date to receive a refund. Troops who want to postpone a reservation due to low enrollment and reschedule must give 4 weeks' notice in **WRITING** in order to transfer payment to a new date in the current Girl Scout year (October 1 — September 30).

SITE MANAGER

Site managers at Camp Cedar Hill vary. Please call 617-839-2567 and speak to the Site Manager on Duty.

CHECK IN/OUT

- Friday Check In

Check in with the Site Manager on duty between 4pm and 7pm on Friday evening for keys to your site. Keys to the buildings/pavilions are also available in the GSEM Shop on Friday between 10am and 4pm (Staff in the Girl Scout Office do NOT have keys to the units).

- Saturday Check In

Check in with the Site Manager on Duty: 11 AM for Day Use rentals and 4 PM for Overnight rentals to obtain keys to your site. Friday groups have until 10 AM to check-out. Do not expect to gain access to the site until after they leave. Keys to the buildings are also available in the GSEM Shop on Saturday between 9 am and 5 pm.

- Parking/Cars

When arriving at Cedar Hill, have the girls wait for others between the office and Great Hall. The parking lot often becomes very busy and can be very dangerous for both children and drivers. Once you've picked up the keys, ONE car with food and troop equipment will be permitted to drive to your site, road conditions permitting. This car remains there for your entire stay and may not leave the site except for an emergency. All other cars in your group must park in the main parking lot. Groups must walk themselves and their personal gear to their campsite. Troops using Four Winds and Beehive may unload at the back gate after first checking in at the front office. Limited parking is allowed at the back gate. If girls will be joining your group late or departing early please be sure parents have the name and location of your cabin. You must inform them that they cannot drive into camp.

- Check Out

Check out time is 10 AM for all troops and groups. Please confirm earlier check-out time with on-duty Site Manager when you arrive. When you are ready to leave, return keys, troop camp check-out list and any borrowed equipment to the Site manager. He will check your site after your departure. If you submitted a refundable damage deposit check, any cleaning or damage fees will be deducted from your damage deposit. The damage deposit will not be returned unless a completed check-out list is received. If your damage deposit was secured with a credit card, you will be contacted regarding any additional cleaning or damage fees.

GSEM VOLUNTEER POLICIES AND PROCEDURES

- Smoking, Alcohol, Drugs and Weapons

Smoking is not permitted anywhere on GSEM property. This includes transportation to and from Council properties. The use of alcohol and drugs is not permitted on any Girl Scout Property. No weapons are allowed on Council property.

- Pets

Pets are not permitted for any reason. Please do not try to keep any found wildlife (e.g., frogs, birds, etc.) as pets.

Valuables

Camp Cedar Hill is not responsible for personal equipment (i.e., sports equipment, pocket knives, musical instruments, etc.) brought to camp.

Community Living/Consideration

Quiet time in camp is 10 pm. Groups are expected to reduce noise levels and if taking night walks to respect the rights of other campers by avoiding areas directly adjacent to tent or cabin sites. Consideration of other campers at all times during your stay is appropriate Girl Scout behavior.

SERVICE PROJECTS

Your help is always welcome. Please clear all projects with the Site Manager on Duty at 617-839-2567, two weeks prior to your arrival.

WINTER SPORTS

Winter can be a wonderful time of year at Cedar Hill. Sledders can use the hill near the Rookery at your own risk. No ice skating is allowed on the pond.

SITE SPECIFIC INFORMATION

- Amy Brewer Shelter, the Forge and Playfield are normally shared by all site users, however, occasionally a group may reserve one of these sites for their exclusive use. Please call 857-453-5302 for more information. There is a charge for reserving these sites.
- The **pools** are not available for troop or group usage. Please don't climb the pool fence.
- The **farmhouse** is a private home. Please do not sit on the lawn or cut through the yard.


NOTE TO LEADERS AND PARENTS

Girl Scouts of Eastern Massachusetts does not spray for ticks or mosquitoes.

Each camp is unique in regards to standing water and the potential breeding ground for mosquitos. Earlier this summer a few state and local communities near our camp locations sprayed for mosquitoes, however you should never rely on spraying alone. We recommend everyone follow the precautions they are hearing on the news or can be found on the MA Department of Public Health Website (http://www.mass.gov/eohhs/gov/departments/dph/).

- Wear mosquito repellent when outdoors during peak mosquito hours (dusk to dawn).
- Weather permitting, wear long sleeves and long pants when outdoors during peak mosquito hours.

In an effort to increase awareness of Lyme Disease, the Department of Public Health asks all parents to conduct daily "tick checks" to help prevent infection. Remember: Not all ticks carry Lyme disease. For more information please go to www.state.ma.us/dph and click on Public Health Fact Sheets.

EQUIPMENT

- Cook kits are available for rental and can be reserved by contacting Joanna Lenahan at jlenahan@gsema.org. No cooking equipment is provided (i.e., pots, pans, utensils, dishwashing buckets). Troops should plan to bring or rent all equipment including toilet paper, paper towels and trash bags.

- Fire buckets, grates and rakes are available on the site.

PROGRAMMING

- Program activities (such as boating, high ropes, low ropes, archery, etc.) are available for a fee. Please refer to the Outdoor Programs Activities Chart for further information.
- CHALLENGE COURSE EQUIPMENT The Challenge Course equipment IS NOT for troop usage. This includes low ropes, high ropes, climbing walls, Flying Squirrel, etc. Trained facilitators must be with your group to use the equipment. Please refer to the Outdoor Programs Activities Chart for further information.
- BOATING Use of the canoes is prohibited unless you have reserved their use by completing the "Boating and Swimming Facility Reservation Form". All certified persons must be onsite with identification. Review Safety Activity Checkpoints for Canoeing in our Resource Library under Safety. Use of personal waterfront equipment is prohibited. You can also refer to the Outdoor Programs Activities Chart for information on how to use this equipment with a GSEM staff member.

REFRIGERATION

- Most sites have refrigeration units. Please reference the chart above. It is your responsibility to monitor the thermometer for acceptable temperature readings of 40 degrees or below. If not, please notify site manager for correction.

DISHWASHING

- Those troops using tent sites should wash dishes in the method outlined in Troop Camp training. Dishwater should be dumped in the washstand sink, NOT in the woods.

FIRES AND WOOD

- The Waltham Fire Department does not permit outdoor fires except in fireplaces and for cooking purposes only. Build fires in existing fire circles. All Fire Circles have rakes, bucket and grate. DO NOT make new fire circles. Gather only fallen dead wood for any fire. Do not cut green sticks for any reason. Outside fire circles should not be raked, swept or shoveled before or after use. Please leave ashes in the circle. It is not necessary to rake the ground around the fire circle. Check inside fireplace damper or flue before using. Open flue before use and close upon leaving.

TRASH

- Take all trash and garbage to the dumpster at the rear of the Beaver Street parking lot. Be careful not to drop any along the way. Close dumpster after use. Cooking grease should be put in trash. DO NOT dig a pit, wash grease down sink or throw in the woods.

PLUMBING

- Cedar Hill has indoor toilet facilities. There are <u>no</u> showers. Please do not call the on-duty staff person to plunge clogged toilets. A plunger will be available in all bathrooms. If a toilet becomes unusable, mark it out-of-order and report it to the on-duty staff upon check-out. To avoid unnecessary problems, do not dispose of sanitary supplies in toilets.

GSEM Shop

- The GSEM Shop will be open Friday 10 AM -4 PM and Saturday from 9am-5pm. One troop at a time may visit the store when accompanied by an adult. The store carries Girl Scout uniforms equipment and camping supplies, badges, t-shirts, jewelry and gifts.

PHONES

- The telephones in the cabins are for emergencies only. <u>Call collect or use credit card for all calls</u>. Record all calls made on back of your check-out list. Calls not reported and made on your date(s) of occupancy will be

charged to your troop. These phones can also receive incoming calls. Please give parents the number of your cabin for emergency use.

- To make an outgoing call from a cabin, you must dial 9 first. To call cabin to cabin, dial the number listed:



IN THE EVENT OF A SERIOUS ACCIDENT, EMERGENCY OR FATALITY:

1. Attend to the injured and call 911.

Secure doctor, ambulance, and/or police as appropriate. In the event of a fatality or serious accident, always notify police.

2. Keep a responsible adult at the scene.

See that no disturbance of injured party(s) or surroundings is

permitted until the police have assumed authority.

3. Ensure the safety of all children at the scene.

4. Call the GSEM Emergency Number:

This answering service will contact key staff members to assist you.

- 5. Fill out insurance form and First Report of Incident form in writing and include:
 - √ Conditions existing at the time of the accident
 - \checkmark Names and addresses of witnesses
 - ✓ Order of events following the accident
- ✓ Any medical attention, opinion or instructions received from parents (Submit the report and insurance forms to the council within 24 hours)

IN THE EVENT OF A MINOR ACCIDENT:

- Immediately give First Aid and/or transport to an emergency room.
- 2. Call a parent and ask them to come to the site or the emergency room, whichever is appropriate. (If parent(s) cannot be reached, call the designated emergency contact.)
- 3. Continue trying to reach the parent(s) so that they may assume responsibility for medical decisions.
- 4. Fill out insurance form and First Report
- of Incident form in writing and include:
 - √ Conditions existing at the time of the accident
 - \checkmark Names and addresses of witnesses
 - \checkmark Order of events following the accident
 - ✓ Any medical attention, opinion or instructions received from parents

(Submit the report and insurance forms to the council within 24 hours)

IN THE EVENT OF A MINOR ILLNESS:

- 1. Call a parent to come for the child.
- 2. If an adult takes a girl home, confirm someone will be at home to care for the child.
- 3. Never leave a child unattended.

IN THE EVENT OF PROPERTY EMERGENCIES:
